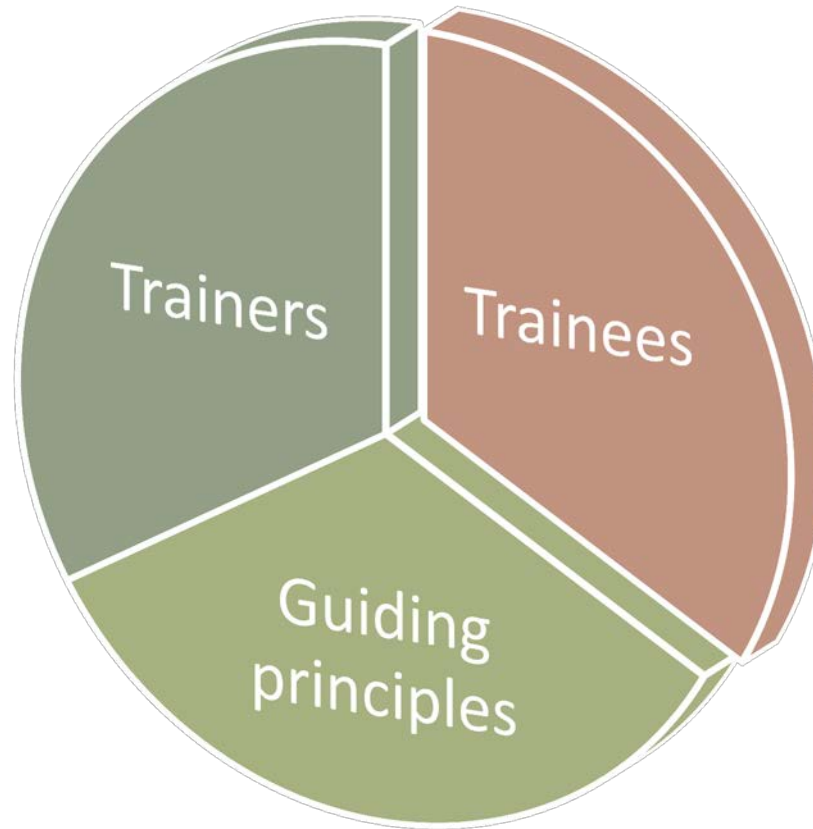


General goals

- Direct nomination



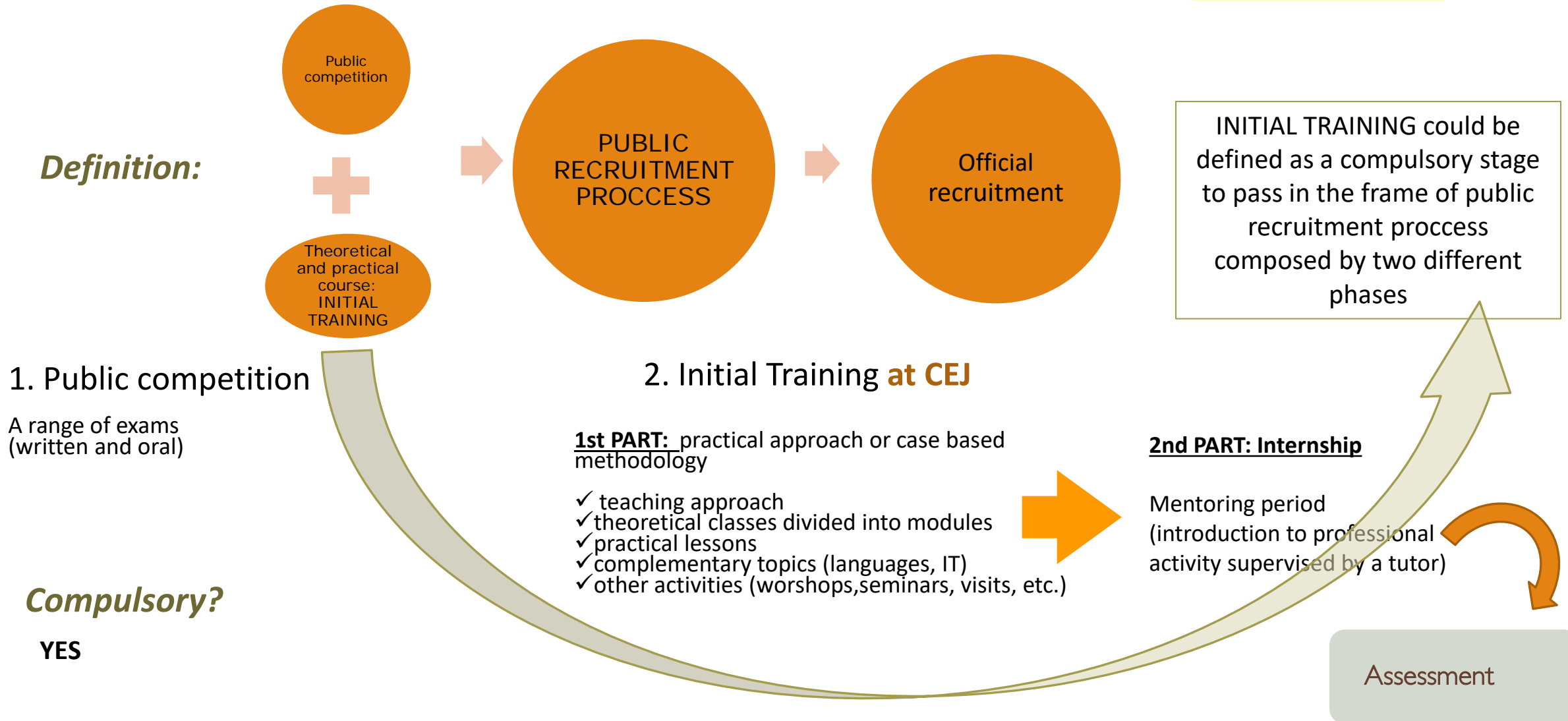

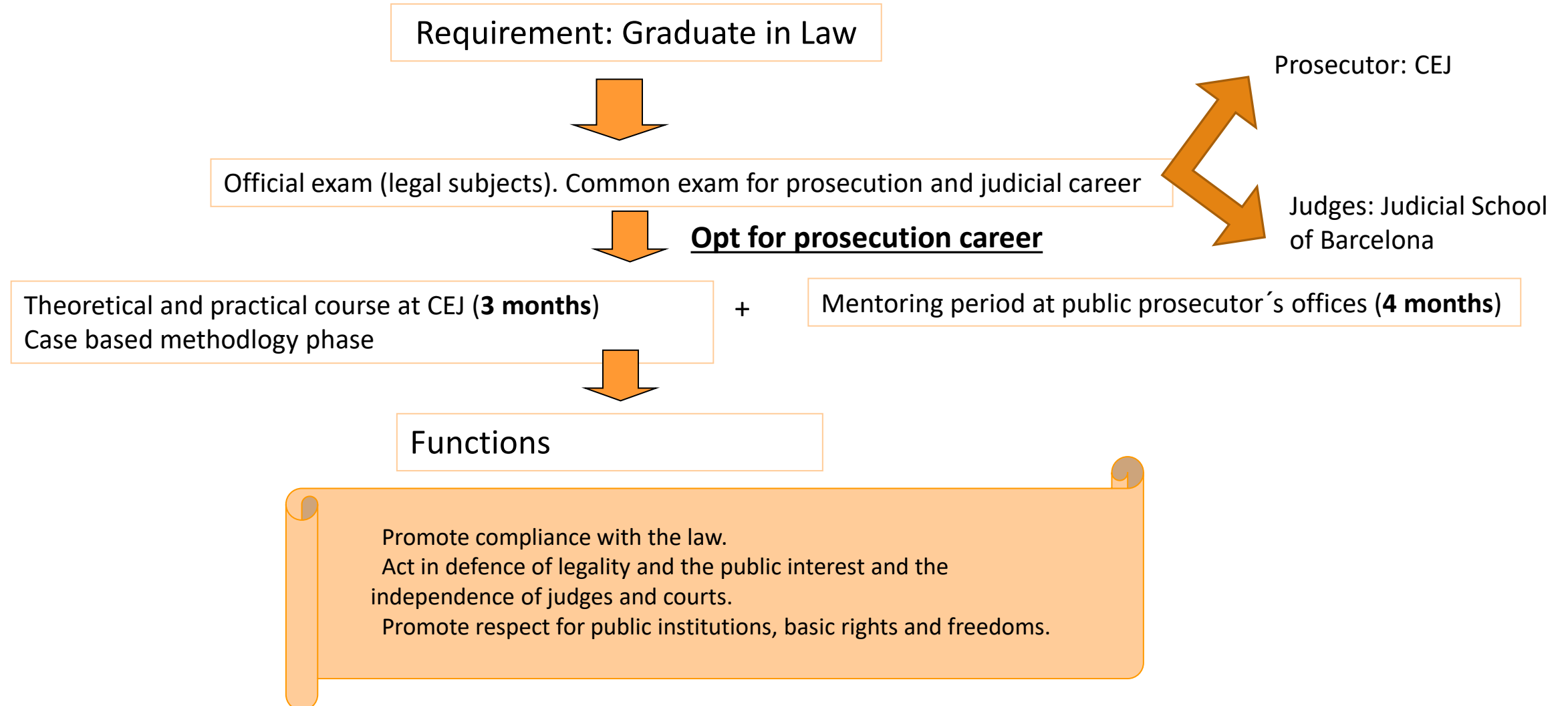

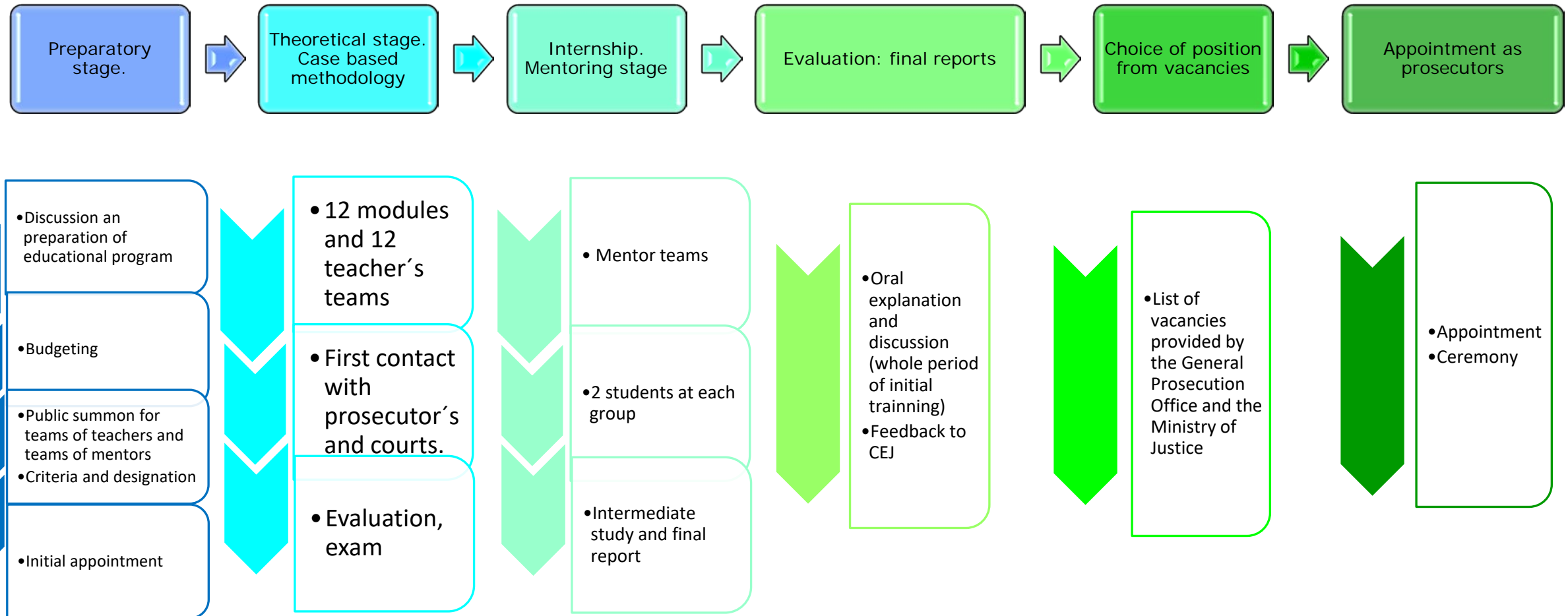
